## Please Observe These Campground Guidelines:

### TERMS AND CONDITIONS

**Open Seasonally: April - October**  
**Check-Out 12 noon | Check-In 2 PM**

**Quiet Hours 10 PM to 8 AM**  
**No visitors after 10 PM**

- Check in at the campground office before setting up at your site.
- Camping is permitted for 14 days in any 30 consecutive day period.
- Maximum 8 people per site. Minors under 18 shall always have adult supervision.
- Parking pass must be always displayed on your dashboard. Campground parking passes are valid at all Lane County Parks for the duration of your stay.
- Each reservation covers either: 1 tow vehicle with a trailer or 2 vehicles per site. Additional vehicles are \$7 per night. Daytime guests shall display a day use or annual parking pass and park in specified areas.

### GENERAL RULES

- All reservations and modifications are subject to a \$10 processing fee.
- Fires shall be always supervised and completely extinguished before departing site.
- Smoking or other use of any tobacco products, including vaping and marijuana, is prohibited in all Lane County Parks and parks facilities, except in designated campsites within campgrounds.
- Pets shall be always attended and keep on a leash no more than six feet in length. Please clean up after your pet.

### PARK SPECIFIC RULES

- Baker Bay is an alcohol-free property.
- Keep your vehicles within your campground site or in the assigned parking areas. Tow vehicle must be present throughout the entire stay.
- Firewood is sold at the campground office. Please do not remove bark or cut limbs from trees within campground.

### REFUND AND CHANGE POLICY:

All cancellations are subject to the following refund terms: 15 Days or More: a full refund of use fees with two options.

**Option #1:** Credit card refund will be issued in the amount of your Use Fee and a \$5 cancellation fee is charged.

**Option #2:** Voucher on account will be issued in the full amount of your Use Fee, but no cancellation fee will be charged.

- 4-14 Days: a credit voucher will be issued in the amount of your Use Fee and a \$5 cancellation fee will be charged.
- Vouchers are valid through the end of the 13th month from the date of issue.
- Cancellations made less than 4 days are not eligible for refund of any kind.
- Reservation Fees are non-refundable and apply to each reserved site.

Campers who fail to notify the campground that they will be arriving later than their reservation's arrival date, and after 24 hours from their arrival date has passed, may forfeit their reservation. Lane County Parks reserves the right to book the site(s) of campers that do not arrive within 24 hours of their reservation arrival date.

If you wish to extend your stay, please contact the host no later than the evening before scheduled check out date.
