PARK RULES AND REGULATIONS

- Children under 18 must be under adult supervision at all times.
- Open flame campfires are not allowed. Propane fire pits are okay.
- **Speed limit is 5 MPH. Watch for pedestrians!**
- Do not park in empty sites or on roadways.
- Do not hang or attach anything from the trees.
- The use of clotheslines is not permitted.
- Generators are not allowed at any time.
- For a complete list of Park Rules, see website.
- All rigs entering RV Park are subject to inspection. Generally, rigs older than 15 years old are not allowed, **No vehicles can be dropped off and left without a tow vehicle available on site for removal.**
- **Only one primary recreational vehicle and one towing OR towed vehicle will be allowed in your assigned site. Do not park any vehicles in vacant sites or storage.**
- **Only paid guests may stay overnight.** Visitors must vacate the RV Park by 10:00 pm.
- **Sewer Hose** must be attached to sewer hook-up with a sealed connection.
- **No Alcoholic beverages are allowed outside of your RV / Trailer space.**
- **ABSOLUTELY no drug use or sales on premises.**
- **Notice the following is not permitted:**
 - No firearms – fireworks – bb guns – drones – no exceptions.
 - There is no storage of any type allowed around, under or on top of the RV, camper and/or vehicle.
 - No vehicle repairs of any kind are permitted.
 - No vehicle/RV washing allowed.
- No selling, advertising or distribution of any product (including alcohol).
- No tents allowed – No box trailers allowed.
- No camper's off trucks.
- No loitering in the RV area. All occupants must be registered with the RV Host and/or have official business with the Fairgrounds Event Center.
- No extension cords.
- No business may be conducted in the RV Park.
- Black or grey water is not to come into contact with the ground. Rinse holding tank basin after each use. If not complied, you will be charged a minimum of \$200 cleanup fee.
- No littering in the RV Park, RV site, RV laundry room or restrooms. This includes smoking materials. Extinguish and properly dispose of all smoking materials in proper receptacles (not on the ground). Place garbage and litter in containers provided.
- Any occupant, guest, their children or their visitors who become a nuisance will be asked to leave the grounds.
- Spreading of any product on the ground to deter insects is strictly forbidden. Please contact the RV Host for any insect issues.
- **All RV Sites must be kept clean for the enjoyment of all guests.**
- **The Sonoma County Event Center at the Fairgrounds RV Park maintains the right to modify the rules and regulations without notice and to refuse entry and/or to evict those who do not observe the RV Park rules and regulations. These rules are for your protection and to ensure all guests have an enjoyable stay. Any rules broken could result in eviction without refund.**

PET RULES

- Pets must be on a leash under your control.
- **All pet waste must be picked up immediately.**
- Do not leave pets unattended.
- No excessive barking or annoying other guests.
- Pets are not allowed in the restrooms or laundry room.
- Dogs/cats running loose will be impounded at the owner's sole expense. Pets are not allowed on the fairgrounds.

QUIET HOURS 10 PM TO 8 AM

Turn off outdoor entertainment and porch/awning lights. No loud music anytime.

CHECK-IN IS 1PM, CHECK-OUT IS 12 NOON SHARP

Early check-in and late check-out are available (for a fee) based on availability.

EARLY DEPARTURE

Sorry, no refunds for early departure.

PARKING & VISITORS

Visitors must check in with the office for a parking permit and pay fees.

LAUNDRY

Code-locked door. Stay with your laundry. Wash is 30 minutes. Dry is 45 minutes.
