"Greensport" was founded by pioneer Jacob Green, born in 1767, who came to northern St. Clair between 1818-1820, during the time of Alabama becoming a state. Jacob Green was one of two Revolutionary War Veterans in St. Clair County and served beside George Washington at Valley Forge. He is buried at the nearby Hopewell cemetery.

Eventually, the Evans family joined the Greens by marriage, and their Greensport Marina, remains as a marker to a once vibrant village. It was a glamorous age that lasted some 50 years and involved more than 40 different steamboats, but change was again in the wind. It seems W.P. Lay had even bigger ideas for the Coosa. Green's Port shortened to Greensport and operated as a port on the Coosa River, later operating a ferry which transported cars and people across the river. David S. Evans, Sr., along with his son, David S. Evans, Jr., were the last to operate the ferry. The ferry now lies beneath Neely Henry Lake at Greensport. Dave Evans Jr. recently passed at the age of 91, leaving the 7th and 8th generation to help continue the family legacy.

Camper Responsibilities

- All guests must register themselves and ANY guests visiting. Anyone over the age of 18 will be required to present ID at time of check in. All fees must be paid upon arrival. Notify the office if you are expecting visitors. There is a \$5/person charge for guests and a maximum of 8 people per site at any given time.
- Absolutely NO parking in ANY grassy areas.
- Check-In Time is 1:00 PM or after. If arriving later than 7:00 PM, please let the office staff know. Check-Out Time is 12:00 PM.
- Pets: MUST be on a leash at all times when outdoors, except when in dog park. Pets cannot be left unattended and are not allowed in any park building, pool, or playground areas. Disruptive or aggressive pets will not be permitted. OWNERS MUST PICK UP AFTER THEIR PETS! No one likes to step in doggie poo. Management reserves the right to refuse any animal it deems dangerous, disruptive, or a threat to other visitors.
- Golf Carts/ATVs: No one under the age of 16, without a driver's license, is allowed to operate any motorized vehicle on our property. We DO NOT allow 4 Wheelers. No golf cart or ATV is allowed to be in ANY grassy area, to include hiking trails. Golf Carts and ATVs must be registered at the office with proof of insurance showing liability coverage. Registration of golf carts or ATVs can be revoked at any time. No one under the age of 18 can rent or operate a rented golf cart.
- Pool: ALL POOL USERS MUST OBTAIN A POOL PASS VIA THE APP AND WRISTBANDS UPON CHECK-IN. ONLY CAMPERS WITH WRISTBANDS HAVE ACCESS TO THE POOLS. Hours are 9:00am to 9:00pm. Guests must not wear a swimsuit that has been worn in the river as it contaminates the pool. ALL POOL USERS MUST BE REGISTERED CAMPERS AND BE IN ATTENDANCE WITH THEIR GUESTS WHO HAVE REGISTERED WITH THE OFFICE. No lifeguard on duty and use of the pool is done at your own risk. Children under the age of 13 must be accompanied by an adult. Posted pool rules must be followed. Glass containers are not allowed in the pool area. Use of pool can be revoked at any given time. I acknowledge that swimming and use of the pool area involves inherent risks, including injury or drowning. I voluntarily assume all risks associated with pool use and acknowledge I am responsible for all persons at my site. Shower before entering the pool. Infants and toddlers must wear swim diapers. Do not enter the pool if you have any open wounds, sores, contagious illnesses, diarrhea, or any other conditions that may compromise pool sanitation.
- Laundry: Coin-Operated machines are available for use at the main office and at the Bathroom in the 300 section. Clotheslines are prohibited. NO PETS OR SMOKING ALLOWED IN LAUNDRY.
- Mail: We do not allow postal mail to be received at the park. Receiving any packages or mail at the park automatically releases Greensport RV Park, LLC as well as Greensport Marina, LLC from any and all liability associated with your mail or package deliveries. No member or management or team member may sign for any package.
- Garbage: DO NOT LEAVE BAGGED GARBAGE OUTSIDE OF YOUR CAMPER. Dumpsters are provided for your use in labeled sections of the park. No garbage is allowed in the fire pits. Cigarette butts are not to be thrown on the ground, but disposed of properly. There will be a \$15 site cleaning fee if we have to clean out a fire pit due to trash, clean cigarette butts out of your site, or pick up doggie poo.
- Boats and Trailers: We do not allow boats and trailers to be parked at your campsite. There is a designated parking area across from the office with plugs. There are two boat ramps available for your use as well as marine gas.
- Quiet Hours: 10:00 PM to 6:00 AM. Please be considerate of others. No disorderly conduct will be tolerated. If the situation arises, management reserves the right to deny the remainder of stay without refund.
- Miscellaneous: No generators allowed. No open display of alcoholic beverages. NO TENTS OR TARPS ALLOWED. No smoking in any park building, including the bathhouse. Anyone operating a bicycle after dark must have proper lighting on it for safe visibility. Campfires are permitted, however, they must be contained in a fire pit and are the responsibility of the registered guest. Firewood storage must be in a rack, off the ground, and no larger than 3'x3'. Guests are responsible for being weather-aware and taking necessary precautions in the event of severe weather. Greensport RV Park, LLC is not responsible for limbs or debris causing damage to campers. All rented sites must be kept neat and clean, as well as free of clutter, at all times. Temporary dog fencing must be on the gravel pad only and is not allowed in the grass as it tears the grass up and restricts lawn maintenance. Outdoor string lights must be 6' or higher off the ground for maintenance purposes. No permanent structure of any type is allowed, this includes satellite dishes being installed in the ground. 
