

RV HIDEAWAY CAMPGROUND RULES & GUIDELINES

Thank you for being our guest, we are delighted you have chosen to stay at RV Hideaway Campground. Please observe the following guidelines. Their purpose is to ensure your safety, consideration of your fellow campers, and an enjoyable stay.

- 1) For assistance when the office is not open, you may contact the staff member whose site # is posted on the office door or call 251-965-6777.
- 2) A dumpster for garbage is located at the Southwest end of the park: please place bagged, household garbage in the dumpster. Make sure that all cardboard is flattened out.
- 3) **SPEED LIMIT IS 10 MPH WITHIN THE PARK.** Only one vehicle is allowed per site.
- 4) **NO PARKING AT THE CLUBHOUSE.** This is for loading & unloading only.
- 5) Quiet hours are from 10pm-7am. Please be considerate of your neighbors by controlling the level of noise at your campsite.
- 6) No open fires are permitted. No **FIREWORKS** or **FIREARMS** (outside your unit).
- 7) Your **PETS** are welcome as part of your family, however, they **MUST BE ATTENDED & KEPT ON A LEAD NOT LONGER THAN 6 FEET WHEN NOT INSIDE YOUR CAMPER** and you **MUST** clean up after them. Pets are **NOT ALLOWED** in any buildings. **PERSISTANT BARKING** is unacceptable behavior & termination of your stay may result.
- 8) No RV's over 10 years old allowed without approval of management.
- 9) Sewer lines must have: a sewer hose seal, be kept tight & free from leaks, and have a "SLUNKY" or similar support system to keep your sewer line off the ground. Each RV must be temporarily connected with the park's sewer and water system.
- 10) Drainage of water, soap, grease or any other waste product onto the ground is a violation of State Law. Use a suitable holding fixture for waste, and dispose of properly. **PLEASE DO NOT PUT ANY GREASE OR SOLIDS INTO OUR SEPTIC SYSTEM.**
- 11) Lots must be kept neat and clean, no rubbish, cans, etc. **APPLIANCES ARE NOT** to be visible outside your camper. If you have excessive "yard art" you shall be responsible for maintaining your on lawn.
- 12) All guests must register at the office; a fee of \$2.00 (plus tax) per person/day will be charged for those over the age of 17 that remain overnight. Children under 14 must be supervised at all times. All occupants and guests are expected to act in an orderly manner and obey the campground rules. Any unreasonable conduct may result in you being vacated without a refund. If you are not a registered guest, you are trespassing.
- 13) Site rent is for (2) adults and no more than (2) children under the age of 18.
- 14) Rent is due on or before the due date. **A \$50 late fee shall be added to your rent after being in arrears for more than 5 days.**

- 15) ATV's or four-wheelers are not allowed in the park.
- 16) Please check with management about washing cars and camping units.
- 17) Clotheslines erected on the campground are not permitted (this includes a line put up between trees)
- 18) No overhauling or repairing of cars, boats, motors, etc. in park. No unsightly or unlicensed cars are allowed in the park. If emergency repairs are required, please notify the office or staff member prior to doing repairs. All camping units, automobiles, boats, ect. must be maintained to factory manufactured condition and in good working order. All units must be kept clean, with an up to date license plate and registration.
- 19) **CHECK IN & CHECK OUT TIME IS 12 NOON.** Please re-register as early as possible if you wish to stay longer.
- 20) The park does not have storage space for boats, extra vehicles, trailers, etc. on the sites, however there is storage onsite available, please inquire at the office.

Termination of your stay may result from the violation of any park rules or objectionable conduct. Termination is at the discretion of the management. The campground, owners, and management, assumes no responsibility for accidents, injuries, or losses of any kind from any cause; occupants hereby agree to indemnify and hold harmless the owners and management. Occupants further agree to abide by any additional rules and regulations which may become necessary, as determined by the owners of the park, to provide for a safe, desirable, attractive and proper place for persons to visit. Failure to enforce any of these rules shall not constitute a wavier of the rule. No waiver of any rule shall be deemed to have been made unless expressed in writing and signed by the owner.

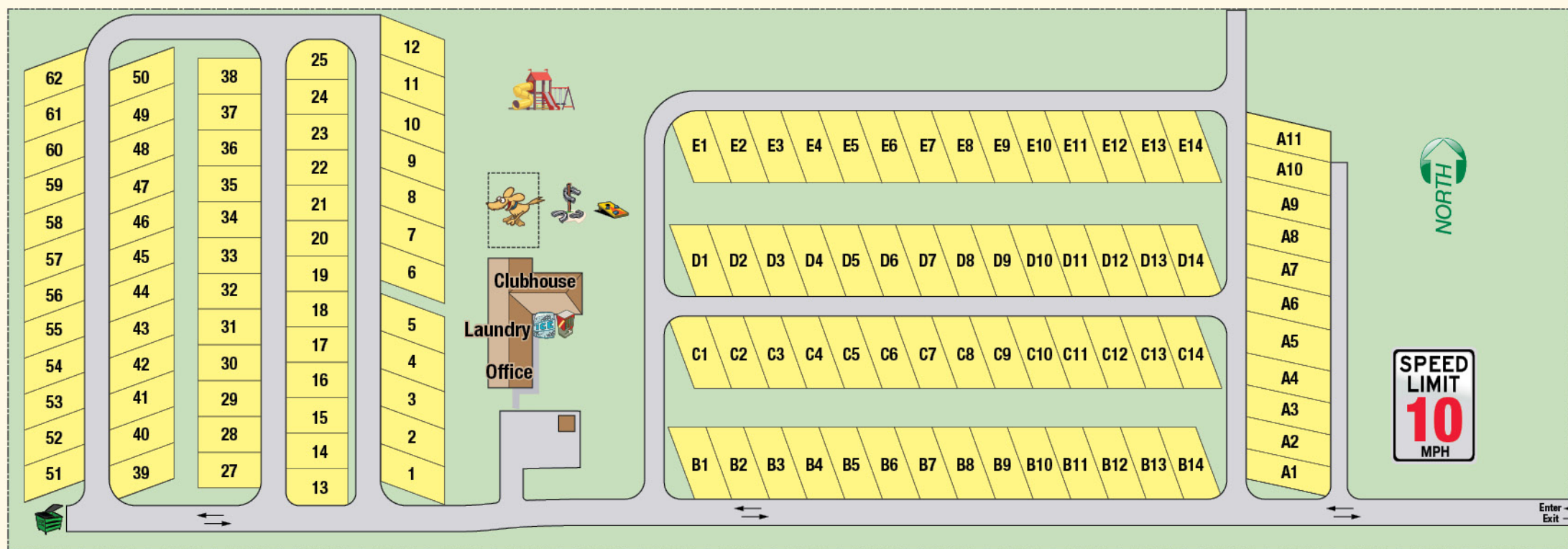
